 - The Board received a "New and/or Replacement Equipment/Tool Request" sponsored by Tom Smith to replace the existing 8" Grizzly Jointer with a 12" Jointer to accommodate larger material and improve quality. The Board unanimously agreed to table the request until the Calibration and Maintenance Team and Equipment Needs has had an opportunity to evaluate the "life cycle" of all Shop equipment, in association with HOA Maintenance to determine the best replacement policy for all equipment as our equipment is 11 years old.
 - Festool vacuum: Jann Campbell is developing a proposal that will add dust collection to the Festool Kapex for improved dust collection. The Kapex was designed to use the Festool Extractor.
 - Table saw out feed top replacement led by Dave Dietz
 - Consumables: Jim W and Carolyn Y will review current inventory list and recommend a standard Consumables list.
